

MINUTES OF THE COMMONS & HAMS COMMITTEE MEETING HELD ON THURSDAY 21ST JANUARY 2016 AT 3.00 PM AT KEMPSEY COMMUNITY CENTRE

PRESENT: - Cllr Waller (Chair), Cllr Bevan and Cllr Bannister and Cllr Geens (delayed arrival)

IN ATTENDANCE: - 3 Members of the Public.

- 1. Apologies: Cllr Michael (Meeting at MHDC) and Cllr Pugh (work) accepted
- 2. Declaration of Interests:
 - 1. Register of Interests: Councillors' were reminded of the need to update their register of interests.
 - 2. Disclosable Pecuniary Interests (DPI) Cllr Pugh declared a Disclosable Pecuniary Interest owning Commons Grazing Rights on Ashmoor, Normoor, Kempsey, Stonehall and Kerswell Green Commons
 - 3. Other Disclosable Interests (ODI) -None

The meeting was adjourned for Public Question Time, notes of which are appended to these minutes

- 3. Minutes: Having been previously circulated the minutes of Commons & Hams Committee meeting of 16.10.15 were approved. Minutes of 03.11.15 were deferred.
- 4. Cllr Waller confirmed three contractors had expressed an Expression of Interest in cutting the gorse on Kempsey and Stonehall Commons. The Committee agreed that they would be invited to tender using various price options i.e. how much gorse can be cut for £2.5K, £4K, £5K and £6K with a split invoice of £2.5K to be paid from 2015/16 budget and up to £6K from 2016/17 budget.
- 5. Caravan Park access track consultation with local residents Agreed to revert to confidential session at the end of the agenda, to discuss this item, due to Legal implications.
- 6. Code of Practice for horses on Commons

Cllr Waller is developing a draft document based on:-

- a. Code of Practice for the Welfare of Horses, Ponies, Donkeys and their Hybrids (Defra)
- b. Code of Practice for Tethering Equines (National Equine Welfare Council)
 He will circulate the draft document, prior to recommending the Parish Council that a Public Consultation is held.

A meeting has been arranged with Democratic Services at the Council Chamber MHDC at 10am on Wednesday 27th January 2016 regarding Commons Bylaws. Cllrs attending to be confirmed.

- 7. A request has been submitted to Professor Jane Memmott of the Botany Department, Bristol University, regarding a collaborative project to survey the rare plant species on Ashmoor Common. regarding drawing up a management plan for Ashmoor Common. Unfortunately no response has been made to date.
 - RECOMMENDATION: To write to Worcestershire Wildlife Trust and Gloucester University to enquire about carrying out the rare plant survey on Ashmoor Common.

PUBLIC QUESTION TIME

Sally-Ann Collins – Stonehall Common

Raised concerns about how the Parish Council could identify the horse/owner in the event of a problem (especially given the quantity of horses)

Would it be possible for the Parish Office to collate a portfolio i.e. Horse passports?

Cllr Waller responded that the Parish Office was evaluating the practicalities of maintaining a database of horses grazing the Commons.

Andrea Halford - Kempsey Common

Raised concerns over the sheer quantity of horses. She suggested the Parish Council compiles a list regarding the turnout of horses and suggested means by which horses could carry identifying tags/markings.
