Cllr Geens confirmed photographs of suspected structural faults in the bridge, over Hatfield Brook which links two fields belonging to the Church Lands Trust had been referred to them.

He confirmed he had approached the Equine Hospital located in Ripple to seek some advice concerning Horse fouling. Unfortunately they could not be of any assistance. An alternate approach is to be looked into.
