

MINUTES OF THE PARISH COUNCIL MEETING OF KEMPSEY PARISH COUNCIL HELD ON MONDAY 14th AUGUST 2017 AT 7.30 PM, AT KEMPSEY COMMUNITY CENTRE

- 2. **RESOLVED**: Following the opportunity for Councillors to ask questions, Mr Russell Varley was co-opted to fill the Councillor Vacancy by paper ballot.
- 3. **RESOLVED**: Cllr Varley was appointed to Recreation, Environment & Commons & Hams Committees.

 - 4. Neighbourhood Development Plan (NDP) Update (*Cllr Smith*)

 The NDP was passed by MHDC for referendum. This will take place on 5th October 2017 at the Parish Hall. MHDC will run the election but are to remain neutral. The Parish Council has previously minuted their support for the document but are not allowed to campaign. However the NDP Working Party will become the Neighbourhood Plan Campaign Group to carry out this function.

A flyer has been prepared, to assist the new Neighbourhood Plan Campaign Group which is promoting the Neighbourhood Plan Referendum. It is anticipated the flyer will be delivered to all parishioners. Cllr Smith will arrange the first meeting of the Neighbourhood Plan Campaign Group to action further.

a. The initial proposal was amended. The amended proposal states 'To use budgeted NDP Funds of up to £3.5K to support the referendum, at the discretion of the Clerk and Chairman, with up to £2.3K being under the control of the Neighbourhood Plan Campaign Group'.

RESOLVED: To accept the above stated amended proposal.

10. Committee Report Updates and Proposals

1. Environment: Cllr Smith

The Rocky Interpretation Panels are ongoing.

Dog Fouling – MHDC were happy to provide some leaflets but insisted on installing signs themselves.

2. Commons and Hams: Cllr Waller - Update:

Ashmoor Common

7 Cattle have been purchased. They are due to be TB tested in October prior to selling them through an agent instead of the cattle market.

Maintenance issues - The ragwort has been partially pulled. The brambles are due to be cut. In the process of liaising with Natural England to improve the fences. The contractor has dealt with the overhanging tree. Chris Gove to top Ashmoor in September.

Bird survey – Awaiting a report from Mr Box.

Kempsey Common

Hard surface track to the caravan park – Currently liaising with Doorbars.

Cllr Waller to devise a letter for the Clerk to issue to two allotment holders re: fencing.

Bramble/Gorse control to be looked at.

No action regarding replacing the missing/damaged posts as they may have to be removed to accommodate the hard surface access track to the caravan park.

Normoor Common

The access track to Mis Moorhouse's cottage was cut by the Lengthsman, failing action from the appointed contractor.

Mr Steve Coole has cut the grass and removed the hay.

A complaint was received that children were making a bike track on the common.

Kerswell Green

Maintenance issues - One poplar tree needs to be removed – Advice is being sought. It was reported a lorry became stuck in the ditch on the track to Kinnersley Engineering. More information is required to understand the full extent of the problem.

Stonehall Common

The grass has been cut.

The access gate (on the west side) is to be fitted.

Worcestershire Wildlife Trust is looking at ways to improve the management of the common. They are offering advice on Community Engagement. Cllr Waller to follow up.

It was noted there are no Dog Fouling Signs on the Lower Ham and those sited by MHDC on Stonehall Common were placed in the wrong location.

Lower Ham – The Committee were of divided opinion as to whether the Lower Ham should be cut or not, following praise of the different variety of birds sighted there as a result of it not being cut. Reference was made to the awful mess of the riverbank and what could be done to improve this area.

Allotments - acquisition of land.

Cllr Michael is looking into the viability /options of securing allotments.

- a. **RESOLVED:** For the C&H Committee to carry out a consultation with local residents in the vicinity of the caravan park adjacent to Kempsey Common regarding the construction of a hard surface track to the caravan park.
- b. The proposal was amended to state 'Proposal for additional dog fouling notices to be placed at entrances to any public areas used by dog owners.'

RESOLVED: To accept the amended proposal.

RESOLVED: The amended proposal was then voted on and accepted.

3. Recreation: Cllr Frazer-Cann

Wicksteed have now replaced the 'spinner' piece of play equipment. This is now fully functional and of a different design. After waiting for many months, there was no communication from Wicksteed as to when this was actually carried out. (A note to grease the bearings will be added to the annual inspection list).

A request was made by WMAS that the defibrillator ID number is clearly indicated on the outside of the defibrillator cabinet. This had been checked and is compliant.

Cllr Michael reported that following a successful cycle event held at the Youth Centre building a chain and padlock had disappeared from the entrance gate from the playing field onto Napleton Lane. This has now been replaced and made secure.

- a. **RESOLVED:** To accept contractor quotation to cut two Hawthorn bushes interfering with BT cables in Napleton Lane. Please note as this is under £250 expenditure it was delegated to the Clerk to arrange.
- 4. Community Centres: Cllr Michael
 - a. **RESOLVED:** For Magic Moments Day Nursery to erect a lean to structure to the rear of the Community Centre building.

A letter is to be written outlining the conditions. Clerk to notify the Insurance Company. In the next week work will be carried out to install LED lighting, decorating and hedge removal at the Youth Centre.

A lock has been fitted to the cellar door at the Community Centre to make secure.

Referred to the children's play boat from The Anchor Inn and reported on the chain of events leading to this piece of equipment being removed and relocated elsewhere.

Reported on the road closures up Post Office Lane, creating problems with access. The sewage pipe has been installed and now Severn Trent are trying to install a new water main and new stop taps to all properties but are experiencing problems.

Malvern Hills District Council have been having great difficulty in trying to get to empty the bins and collect rubbish from Post Office Lane as a result.

He confirmed to S106 and Planning in that there is no specific timescale for completion of play area in Public Open Space.
