

**MINUTES OF THE RECREATION COMMITTEE MEETING OF KEMPSY PARISH

1. Cllr Campbell was re-elected as Chairman.

4. Minutes: Having been previously circulated the minutes of the 27.01.14 were signed as a true and correct record. Cllr Campbell asked if a start date could be established from HTE Solution Ltd for emergency lighting to be installed in The Pavilion.
5. It was agreed to order two further rowan trees to replace the rowan tree removed by Western Power Distribution from the tree line at Plovers Rise playing field. These will be planted to the left hand side of the drive.
6. The removal of waste at the playing field was considered. A recommendation is to be placed on the July agenda following two further quotes. This service will be paid for from The Recreation Committee budget.
7. The Committee felt signage stating 'Kempsey Sports Pavilion' would help to identify the building. Cllr Hay to liaise with Cllr Stevens concerning incorporating the logo sign onto the new signage. Cllr Campbell to liaise with Cllr Geens who is pursuing signage for the Community Centre in respect of placing an order.
8. Cllr Campbell to investigate and apply for a grant of £12K to add to the allocated budget of £3K to assist in purchasing several pieces of outdoor gym equipment to be installed on the playing field.
9. Any Other Business  
Cllr Campbell to liaise with Mr Androlia concerning the Land Registry of the Tennis Club (Title No: WR145924) and if necessary seek further advice from the solicitors.

Cllr Campbell advised that The Parish Council could expect a letter from Kempsey Colts to request a larger storage container to replace the smaller one they already have in situ.

Monthly playing field inspections are due to be carried out by Committee members on a rota basis. To be included on this inspection – to monitor driving as vehicles have been parking in front of the storage container in front of the pavilion and dislodging the kerb stones.

Cllr Hay reported graffiti on the basketball hoop. It was established this belonged to The Parish Council. Cllr Hay agreed to inspect and remove the graffiti.
