## PUBLIC QUESTION TIME

### David & Mrs Morris, William Halford

Reiterated concerns expressed at previous meetings at potential damage to Kempsey Common and danger to walkers resulting from excessive numbers of horses on the common exacerbated by supplementary feeding due to over-grazing at a time when the surface is very wet and soft and subject to poaching and treading by the livestock. They drew attention to the dossier they submitted in support of their contention that supplementary feeding is illegal.

The Committee emphasised the 2006 Commons Act does not prohibit supplementary feeding but agreed to have a further look at their concerns.
