

**MINUTES OF THE RECREATION COMMITTEE MEETING OF  
KEMPSEY PARISH COUNCIL HELD ON

1. Apologies: None
2. Declarations of Interest
  1. Register of Interests: Councilors were reminded of the need to update their register of interests.
  2. To declare any Disclosable Pecuniary Interests in items on the agenda and their nature - None
  3. To declare any Other Disclosable Interests in items on the agenda and their nature – Cllr Stevens declared an ODI residing on The Limes.
3. To Consider Written Requests from Councillors for the Council to Grant a Dispensation (S33 of the Localism Act 2011) – written requests to be submitted to the clerk prior to the Meeting - None.

4. Having been previously circulated the minutes of the meeting held on 03.06.13 were signed as true and correct record.
5. It was agreed that a proposal should be made on the August agenda to grant permission for Kempsey Tennis Club to install a storm shelter (4m long x 2m high x 2 m deep - 12 people capacity) in a green colour, with the club members to bear the full cost of purchase and installation and maintenance.  
  
A further proposal was agreed to be presented at the August meeting to resite Kempsey Tennis Club noticeboard flat to the side of the storm shelter.
6. Quotations have been received for the replacement of fencing to the southern boundary. Due to the cost implications and budget restraints Cllr Campbell will pursue to investigate grant opportunities.
7. It was agreed a proposal should be presented at the August meeting to consider accepting a quotation for re-tarring the access drive up to Plovers Rise.
8. It was agreed a proposal should be made on the August agenda to consider the purchase and installation of two pieces of outdoor gym equipment (Space Walker and Surfer) for the playing field at Plovers Rise. (Napleton Lane – East Gate). Cllr Campbell to obtain prices.
9. Quotations are in the process of being obtained to replace the damaged fencing behind the pavilion.
10. A proposal is to be presented on the August agenda to instruct SME Solicitors to act for Kempsey Parish Council in respect of purchasing The Limes Green, Kempsey from Malvern Hills District Council at a cost up to the value of £2K. Clerk to liaise with SME to enquire if pre contract searches are necessary.
